**RESOLUTION AUTHORIZING AND APPROVING THE
CONTINUATION OF THE USE OF SCFC 2015 GRANT APPLICATION
COST SHARING FUND TO ASSIST WITH GRANT APPLICATIONS FOR
FINANCIAL ASSISTANCE FROM FEDERAL AND NEW YORK STATE
PROGRAMS**

WHEREAS, on March 9, 2015, by resolution #01-15, SCFC created the SCFC 2015 Grant Application Cost Sharing Fund (“Cost Sharing Fund”) which was funded by a \$100,000 payment received from the Millennium Pipeline Project; and

WHEREAS, the entire amount available from the Cost Sharing Fund to provide grant application assistance was not expended in connection with 2015 grant applications; and

WHEREAS, by resolution 01-17, SCFC authorized the use of Cost Sharing Fund for future grant applications plus an addition of up to Thousand and 00/100 (\$30,000.00) Dollars subject to the conditions of Resolution #01-15; and

WHEREAS, SCFC wishes to authorize the use of Cost Sharing Fund for future grant applications plus an addition of up to Thirty Thousand and 00/100 (\$30,000.00) Dollars, which addition shall be administered subject to the conditions of Resolution #01-15.

NOW, THEREFORE, BE IT RESOLVED by the Sullivan County Funding Corporation as follows:

Section 1. SCFC hereby authorizes use of the remaining balance in the Cost Sharing Fund plus an addition of up to Thirty Thousand and 00/100 (\$30,000.00) Dollars, which addition shall be administered subject to the conditions of Resolution #01-15.

Section 2. This resolution shall take effect immediately.

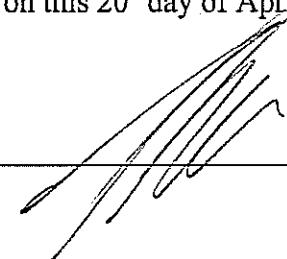
