## III. NEW BUSINESS

Chairman Steingart referred to the proposed resolution authorizing funding for the **Southern Catskills Regional Food Hub**. Mr. Rieber made a motion to discuss the resolution, and Mr. Guenther seconded the motion. Mr. Barbuti recused himself

from the discussion because he is the Town of Liberty Supervisor and the project is located within the Town of Liberty. Board members discussed the resolution, including the creation of a not-for-profit to run the hub, and a proposed memorandum of understanding between SCFC and the new not-for-profit outlining the latter's plan for the food hub as a condition precedent to funding. Following this discussion, the Board voted and the resolution was approved with Mr. Steingart, Ms. Loughlin, Mr. Rieber, Mr. Guenther, and Ms. Roig in favor, Mr. Perrello opposed, and Mr. Barbuti abstaining. Chairman Steingart commented that the food hub fulfills the original mission and intent of the red meat facility project, to assist the agricultural community. Mr. White added that he believes the food hub will be even more advantageous to the farm community, and that the development of the hub is well underway, led by a talented group that will form the board of directors of the new not-for-profit. Speaking as the Town of Liberty Supervisor, Mr. Barbuti commented that he is happy to see the former red meat facility building put to good use in his Town.

#### VI. PUBLIC COMMENT AND ADJOURNMENT

Chairman Steingart asked the Board and those present if there were any questions or comments. There being none, on a motion by Ms. Loughlin, seconded by Mr. Guenther, the meeting was adjourned at approximately 9:15 AM.
