## Resolution No. 3 - 23

RESOLUTION ACCEPTING THE ASSIGNMENT OF THE LOANS AND LOAN FUNDS FROM THE COUNTY OF SULLIVAN (COLLECTIVELY, THE "LOAN FUNDS")

WHEREAS, pursuant to Section 402 and 1411 of the Not-For-Profit Corporation Law of the State of New York ("N-PCL"), SCFC was established for certain charitable and public purposes including, among other things, relieving and reducing unemployment, promoting and providing for additional and maximum employment, bettering and maintaining job opportunities, instructing or training individuals to improve or develop their capabilities for such jobs, carrying on scientific research for the purpose of aiding a community or geographical area by attracting new industry to the community or area, or by encouraging, the development of, or retention of, an industry in the community or area, and lessening the burdens of government and acting in the public interest; and

WHEREAS, by Resolution duly adopted on November 22, 2023, the Sullivan County Legislature authorized the County to transfer the Loan Funds to the SCFC; and

WHEREAS, SCFC has the infrastructure, standards and protocols to loan out and administer the Loan Funds; and

WHEREAS, SCFC desires to authorize its Executive Director to execute an agreement with Sullivan County to accept future responsibility for administration of the Loan Funds.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF SCFC AS FOLLOWS:

- Section 1. SCFC is hereby authorized to accept the assignment of the Loan Funds.
- Section 2. SCFC's Executive Director is hereby authorized and directed to execute an agreement with Sullivan County to accept future responsibility for administration of the Loan Funds.
- Section 3. The officers, employees and agents of the SCFC are hereby authorized and directed for and in the name and on behalf of the SCFC to do all acts and things required and to execute and deliver all such certificates, instructions, documents, and to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or in the opinion of the officer, employee or agent acting on behalf of the SCFC desirable and proper to effect the purposes of the foregoing resolution and to cause compliance by the SCFC with all the terms, covenants and provisions of the documents for and on behalf of the SCFC.
- Section 4. This resolution shall take effect immediately.
